

# Call for contribution: An edited volume on SSF Guidelines implementation challenge

The Voluntary Guidelines for Securing Sustainable Small-Scale Fisheries in the Context of Food Security and Poverty Eradication (SSF Guidelines) is a very rich document, full of issues that deserve more indepth analysis than the SSF Guidelines themselves provide. Implementation of the guidelines, whether at local, national and regional levels, is likely to be full of challenges. Research on the guidelines implementation will certainly help identify gaps and pathways, as well as provide lessons for future efforts.
