a) TBTI at the 11th Asian Fisheries and Aquaculture Forum (AFAF) in Bangkok, August 4-6 , 2016



b) TBTI Symposium on Small-Scale Fisheries in Asia-Pacific Region and Beyond in Kanchanaburi province, Thailand, August 6-9 , 2016

TBTI organized a three-day symposium focused on aspects of SSF that are relevant for the Asia- Pacific region, particularly those related to inland fisheries, values of fish for food security, gender in fisheries, and community responses to global change. The symposium was an opportunity to develop a research agenda and capacity development program needed for promoting sustainable SSF and for the implementation of [the SSF Guidelines](#) in the region and elsewhere.

c) TBTI participated at the FishAdapt: Global Conference on Climate Change Adaptation for Fisheries and Aquaculture in Bangkok, Thailand, 8-10 August, 2016

On August 10th, some 20 participants joined a TBTI special session on **Climate change in small-scale fisheries: Vulnerability, adaptive capacity and responses**. The session aimed at enhancing understanding about the vulnerability of small-scale fishing communities to climate changes, how they respond to different types of change and stressors, and what factors, conditions, instruments and tools can enable small-scale fishing communities to cope and adapt.
