

Effective implementation of the gender aspects of the SSF Guidelines will require fisheries governing institutions that have the capacity and capability to integrate gender research and best practices in their policy and practice.

The purpose of this webinar is to summarize the findings from the recent GAF7 workshop that focused on identifying gender integration capacity and capability indicators for fisheries institutions. The goal is to further define and refine these indicators and measures that can be used in multiple contexts.



A look around the globe: building SSF pictures one question at a time

Short survey about SSF

An estimated 560 million people, or 8% of the global population, directly or indirectly depend on fishing for a living. According to FAO, more than 90% of these people are involved in small-scale fisheries, contributing to food security and poverty eradication, sustaining ecosystems, supporting local communities, and livelihoods, and promoting cultural inheritance. These figures and features suggest that small-scale fisheries are both 'too big to ignore' and 'too important to fail'. Yet, many aspects of small-scale fisheries, starting from what they are, how they are defined and how important they are to the society, remain obscure.

A few years ago, TBTI developed "20 Questions about SSF". These questions resulted from more than two years of consultation with international experts with the aim to capture key characteristics about small-scale fisheries. The 20 questions are available through TBTI Information System on Small-scale Fisheries (ISSF) and are at the core of 'SSF Profile layer' in ISSF, providing information such as ecosystem, gear, market distribution, governance and much more.



Starting this month, TBTI will publish a series of short surveys on small-scale fisheries, which will be based on "20 Questions about SSF".

The first survey in this series focuses on terms and definitions we use when referring to small-scale fisheries in different locations around the world. These surveys are designed to highlight the characteristics of fisheries around the globe as a means to increase their visibility and help design adequate policies and management strategies that support them.

Report from the 3rd World Small-Scale Fisheries Congress

'Supporting the implementation of the SSF Guidelines'



The 3rd World Small-Scale Fisheries Congress, held in Thailand in October 2018, was an opportunity for researchers, practitioners, fisher organizations, CSOs, and policy makers to share up-to-date information about all aspects of small-scale fisheries and to formulate action plans and capacity development programs to support the implementation of the Voluntary Guidelines for Securing Sustainable Small-Scale Fisheries in the Context of Food Security and Poverty Eradication (SSF Guidelines).

This report presents the summary of the discussion about the SSF Guidelines, outlining in particular the roles of governments, CSOs, and research community in the implementation process, and illustrating some of the main challenges and opportunities in the process.

In addition, the report provides insights on what kind of governance transformation is needed for a successful implementation as well as how best to integrate knowledge and foster communications to enhance this process.

From a practical standpoint, the report provides direct examples of how the SSF Guidelines are being implemented in five countries across the globe.

TBTI participates in the conference on 'Empowering Women in the Maritime Community'

Malmö, Sweden, from 4-5 April 2019



In celebration of the World Maritime Day 2019, the 3rd International Women's Conference on the theme "Empowering Women in the Maritime Community" was hosted by The World Maritime University (WMU) in Malmö, Sweden.

The aim of the Conference was to identify opportunities to encourage women to pursue careers in the maritime and ocean sectors, and to call for action from maritime and other stakeholders in support of achieving the United Nations Sustainable Development Goals (SDGs), in particular, Goal 5 related to gender equality, as a cross-cutting theme.



TBTI was invited to partake in the panel session on 'Partnerships and Networking for Gender Equality'. On behalf of TBTI, Milena Arias Schreiber attended the Conference and participated in the panel session.

In her talk, Milena presented TBTI's aims, and activities, highlighting, among other things, the high number of members (more than 500 from more than 80 countries) and publications (including a special issue on (en)gendering change in SSF). She also emphasized how the network has shown to be able to produce rapid and significant results and benefits for its members.

In terms of lessons for success, the talk empahised that the network is open, voluntary, snd shares a concrete common goal, while taking into consideration different perspectives and research interests.
